## British Virgin Islands Ports Authority (Amendment) Regulations, 2020

[Gazetted 18<sup>th</sup> December, 2020]

The Minister, in exercise of the power conferred by section 94 of the British Virgin Islands Ports Authority Act, 1990 (No. 12 of 1990), makes these Regulations.

Citation. **1.** These Regulations may be cited as the British Virgin Islands Ports Authority (Amendment) Regulations, 2020.

Insertion of<br/>Regulation<br/>115A.2.The British Virgin Islands Ports Authority Regulations, 1995 (in<br/>these Regulations referred to as "the principal Regulations") is amended by<br/>inserting after regulation 115 the following new regulation:

"115A. The fees as set out in Item IA of the Third Schedule shall be for security and Gross Vehicle Weight Rating (GVWR).

Second Schedule **3.** The Second Schedule to the principal Regulations is amended

- (a) by deleting Item A and replacing with the following new Item:
  - "A. FEE FOR THE ISSUE OF A LICENCE TO OPERATE A FERRY SERVICE

#### [Regulation 28(3)]

For each passenger the vessel is authorised to carry.....\$4.00 per annum"

- (b) by deleting Item B and replacing with the following new Item:
  - "B. FEE FOR THE ISSUE OF A PILOTS LICENCE AND PILOTAGE EXEMPTION CERTIFICATE

### [Regulation 45]

Pilot's Licence.....\$1,500.00 per annum

Pilotage Exemption Certificate.....\$1,500.00 per annum"

- (c) by deleting Item D and replacing with the following new Item:
  - "D. FEE FOR THE ISSUE OF A LICENCE FOR OTHER SERVICES

  - "(1) Rate for cargo loaded or unloaded
    - (a) per ton weight or part thereof.....\$4.00
    - (b) per ton measurement or part thereof......\$4.00"
- (b) by deleting Item C and replacing with the following new Item:

## "C. RUNNING OF LINE CHARGES

[Regulation 99(3)]

Per foot length of vessel.....\$1.50 per foot of vessel"

(c) by deleting Item E and replacing with the following new Item:

"E. CHARGES FOR WHARFAGE

# [Regulation 102]

2 per centum F.O.B value of cargo landed or loaded"

- (d) in Item F by deleting item (a) and replacing with the following new item:
  - "(a) the first week or part thereof per cubic foot per day.....\$0.25"
- (e) in Item G by deleting items (a) and (b) and replacing with the following new items:
  - "(a) For landing or loading each loaded container.....\$200.00 per TEU
  - (b) For landing or loading each empty container.....\$100.00 per TEU"
- (f) in Item H by deleting items (a), (b) and (c) and replacing with the following new items:
  - "(a) Stevedoring per ton of cargo handled.....\$2.00 per ton
  - (b) Longshoring per ton of cargo handled.....\$1.00 per ton
  - (c) Pilotage.....\$2.00 per foot of vessel draft"
- (g) by inserting after Item I the following new item:
  - "IA.. SECURITY FEE AND GROSS VEHICLE WEIGHT RATING (GVWR) FEES

#### [Regulation 115A]

- (a) Security Fee.....\$1.00 per ton cargo
- (b) Vehicles GVWR less than 14,000lbs.....\$500.00 per annum

- (c) Vehicles GVWR 14,001 to 26,000lbs.....\$1,000.00 per annum
- (d) Vehicles GVWR over 26,000lbs.....\$1,000.00 per annum
